## Section 1: Reporting Approach for 2018 Data:

On June 3rd, 2016, Shire acquired Baxalta. In accordance with the definition of member companies in the EFPIA HCP Code, Shire has made the decision to disclose as one entity starting with the disclosure period of 2017 unless local law requires otherwise.

Due to the complexity of integration between the two companies, Shire would like to highlight the key differences in methodology between the two companies, that still remain.

As of September 1<sup>st</sup>, 2018 Shire divested its Oncology business to Servier. Any transfers of value on or after September 1<sup>st</sup>, 2018, will be reported by Servier. Any transfers of value that happened prior to September 1<sup>st</sup>, 2018, even if for activities after September 1<sup>st</sup>, 2018, will be reported by Shire.

## Section 2: Scope of Disclosure:

The following EFPIA member countries are in scope for disclosure:

Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, , Malta, the Netherlands, Norway, Poland, Portugal, Romania, Russia, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Turkey, Ukraine and the United Kingdom.

Per EFPIA, the following countries have a **full or partial** exception to the Disclosure Code:

1. Belgium
2. Denmark
3. France
4. Netherlands
5. Portugal
6. Romania
7. Slovakia
8. Turkey

Iceland and Luxembourg are not formal member countries of EFPIA but are voluntarily implementing the HCP Disclosure Code.

Shire will publish data based on the local country Code template. If no template is provided by the local country, then Shire will default to the EFPIA Disclosure Code template.

Shire will publish R&D data for the Netherlands, Romania, and Slovakia in the EFPIA Disclosure template as these are not reportable under local law/code reporting.

### Section 3b: Consistent Decisions in Methodology:

Below captures additional decisions that drive our collection, aggregation and reporting process and identifies where there were no differences between Shire and Baxalta for 2018 data and the same Methodology is followed:

<p><b>Transfer of Value Dates</b></p>	<p>Shire used the payment date for monetary payments/TOVs (including HCP Lodging, Transportation and Meal reimbursements) for activities within the reporting period and applied the event date for In Kind TOVs (except DBS or WBK donations).</p> <p>For contracts with services that span multiple periods, Shire used the date of payment as the TOV date.</p> <p>For Italy, Greece and Belgium, based on guidance from the local association, Shire used payment date for all TOVs.</p>
<p><b>Disclosure Currency</b></p>	<p>All payments and TOVs will be disclosed in local currency per guidance from EFPIA, with the exception of Ukraine which is disclosed in EUR. If a payment is captured in another currency, it will be converted into local country currency based on the date at which the TOV occurred and corresponding daily exchange rate.</p>
<p><b>Reconciliation of the Data</b></p>	<p>On an annual basis, Shire will complete a full year reconciliation to identify any transactions that were submitted post data validation or post publication and update the reports accordingly to support the principles of full transparency.</p>
<p><b>Cancellation of events or contracts including when a HCP does not participate</b></p>	<p>Shire will only attribute the TOVs that are incurred and can be reasonably associated to the HCP based on supporting documentation. In the circumstances when a flight or accommodation is booked but the event is cancelled or HCP does not attend, no TOV will be attributed to that HCP.</p>
<p><b>Disclosure of Cross-Border TOVs</b></p>	<p>Shire will disclose based on the <u>principal practice</u> address of the recipient, regardless of where payment is made.</p> <p>Shire relies on IQVIA (previously IMS Health &amp; Quintiles) as a recognized industry leader in data management to determine the principal practice address of the Healthcare Professional (HCP) and Healthcare Organisation (HCO) to be consistent across the EFPIA countries. <i>This may not match with the address collected on the contract, in our finance system of payment or in our other supporting documentation.</i></p>
<p><b>Disclosure Language</b></p>	<p>All disclosures will be made available in English and in the language(s) prescribed in the national codes.</p>

<b>Disclosure of Local Identifiers</b>	To support the principles of privacy, Shire will disclose the “Country Unique Identifier” for HCPs and/or HCOs where this is <b>required</b> based on the local code.
<b>Payment made to Institution for the benefit of HCPs</b>	<p>Shire decided:</p> <ol style="list-style-type: none"> <li>1. If a payment was made to a HCO for the benefit of HCPs and the identity of the HCP was attainable, Shire disclosed only once, and on an individual basis against the relevant HCPs and obtained the appropriate consent.</li> <li>2. <p><b>Disclosure Period</b></p>	<p>Each reporting period shall cover a full calendar year of the prior year.</p>
<p><b>Public Disclosure and Retention Period</b></p>	<p>Per the guidance from EFPIA, Shire will ensure that the information disclosed shall be required to remain in the public domain for a minimum of 3 years or longer after such information is disclosed in accordance with the disclosure method unless, in each case:</p>

<b>Documentation and Records Retention</b>	Per the guidance from EFPIA, Shire will ensure that all the TOVs required to be disclosed must be documented and retained for a minimum of 5 years or longer after the end of the relevant reporting period, unless a shorter or longer period is required under applicable national data privacy or other laws or regulations. (Section 2.07)

**Section 7: Other Definitions:**

<p><b>Blood Sample Collection Kit</b></p>	<p>Any type of material, device or kit used to collect biological samples (e.g. Blood, plasma, etc.) for the purpose to collect, store and transport the biological material necessary for the performance of a diagnostic test.</p>

<b>Dry Blood Spot Kits (DBS Kits)</b>	<p>Dry blood spot collection kits used for the collection of blood samples needed for testing for LSDs and other diseases. Dry blood spot kits are classified as an in-vitro diagnostic medical device.</p>
<b>Professional Congress Organizer (PCO)</b>	<p>A company/individual specialised in the organisation and management of congresses, conferences, seminars and similar events. Commercial companies involved in the organisation of travel (travel agencies) or accommodation (hotels, banqueting functions in hotels, etc.) are not considered PCOs.</p>
<b>Transfers of Value</b>	<p>Direct and indirect transfers of value, whether in cash (Monetary), In Kind or otherwise, made, whether for promotional purposes or otherwise, in connection with the development and sale of generic or branded prescription-only Medicinal Products exclusively for human use.</p> <p>HOW</p> <ul style="list-style-type: none"> <li>• <u>Direct transfers of value</u> - are those made directly by Shire to, and for the benefit of an HCP/HCO/Third Party Intermediary (where identity of HCP/HCO cannot be identified) Recipient.</li> <li>• <u>Indirect transfers of value</u> - are those made through an intermediary (Third Party/PCO) on behalf of Shire for the benefit of an HCP/HCO Recipient, where the identity of Shire is known to or can be identified by the Recipient and where Shire can identify the HCP/HCO that benefits from the TOV.
